

## COVID-19 WAIVER OF LIABILITY AND INDEMNIFICATION

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and the use of face masks, and hand sanitizer.

Eastside Academic Studies has put in place preventative measures to reduce the spread of COVID-19; however the program CANNOT GUARANTEE that you and/or your child(ren), will not become infected with COVID-19. Further, entering Lilburn Alliance Church could increase your and/or your child(ren)'s risk of contracting COVID-19. The waiver, release, and other representation and covenants set forth herein are given in consideration for the Eastside program permitting you and/or your child(ren) to participate in Eastside classes and activities.

1. Acceptance of Risk; Release; Indemnification. I am fully aware that there are risks associated with me and my child(ren) entering Lilburn Alliance Church during the COVID-19 pandemic. I agree that I am personally responsible for my and/or my child(ren)'s safety and actions while participating in Eastside classes and activities. I agree to comply with all of Eastside's policies and rules.
2. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representative, hereby forever release, waive, discharge, and covenant not to sue Eastside Academic Studies and/or Lilburn Alliance Church and their subsidiaries and affiliates and their current, former, and future officers, directors, employees, and agents from any and all damages, injuries, losses, liability, claims, causes of action, litigation, or demands, including but not limited to those for personal injury, sickness, or death, as well as property damages and expenses, of any nature whatsoever which may be incurred, directly or indirectly, now or in the future, in any way related to COVID-19 and in connection with my participation in Eastside classes.
3. I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgements, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my and/or my child(ren)'s participation in Eastside classes and activities due to COVID- 19.
4. By signing below I acknowledge and represent that I have read the foregoing Waiver of Liability, understand it and sign it voluntarily as my own free act and deed, including without limitation the Release of Liability and Indemnification requirements contained in this document. I am sufficiently informed about the risks involved in participating in Eastside classes and activities to decide whether to sign this document; no oral representations, statements, or inducements, apart from foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this document for full, adequate, and complete consideration fully intending to be bound by the same. I agree that this Wavier of Liability shall be governed by and construed in accordance with Georgia law, and that if any of the provisions hereof are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Waiver of Liability as a whole.
